Skate Park Parties Information Sheet

- 1 The reservation fee must be paid in full at the time of reservation in order to secure your date/time. The reservation fee entitles the booking party the use of their party area(s). Unfortunately we are not able to save any reservations without payment. A maximum of two party areas can be booked per party day per family and a maximum of 2 days can be booked per year per family. Must be at least 18 to reserve a party.
- 2 Wrist bands will only be given out on the day of the party for each participant and only upon receipt of the waiver signed by the parent of each child. Wrist bands are \$3 and required for anyone who wishes to enter the Skate Park. There is a minimum of 20 wrist bands and maximum of 30 wrist bands per party area. The minimum payment is due at the time the reservation is made. **Participants will not be allowed in the Skate Park without a wrist band, signed waiver and all required protective gear.**
- 3 If you wish to provide food and drinks to your guests you may do so on your own. The City will not provide any food or drinks. In addition, food and drinks are not allowed in the skating area and must be kept outside the Skate Park. Alcohol, smoking and/or drugs of any kind are not allowed at any City park.
- 4 Please note, there is no storage space (refrigerated or other) available at the Skate Park or nearby facilities, however you may bring coolers.
- 5 The booking party is the individual in charge of the event, and will need to be in attendance throughout the duration of the event. In addition, the booking party will be asked to verify that all conditions are met during the event.
- 6 Decorations are allowed only in your party area but please keep in mind that it is your responsibility to secure all decorations in your party area due to the wind.
- 7 Tables and chairs will be set up by staff no more than 15 minutes prior to the party time and will be taken down 15 minutes after party time. In addition, it is your responsibility to clean up any trash left behind in your party area.
- 8 Changes, alterations, or defacement of property to any facility, its furnishings, or equipment will not be permitted. Any person or group causing damage to property or equipment will be required to pay for current cost of repair, including labor, or replacement to restore furnishings or equipment to its original condition. Until further payment for damage is received, the City of Santa Clarita will deny future application and/or any registration for City classes/programs.
- 9 **All party participants who wish to enter the Skate Park will be required to obey all Skate Park rules (provided in this packet) including all required protective gear. The City of Santa Clarita will not be able to provide any helmets or safety gear to anyone. Please inform all participants that they must bring their own gear.**
- 10 Cancellations requested at least 14 working days prior to the reservation date will receive a full refund. Cancellations made 7-13 days prior to the reservation date will receive a fifty percent (50%) refund. No refunds will be issued after this time.
- 11 Cancellations made by the City: The Skate Park will be closed and all parties cancelled due to rain or water on the ground either the day of the party or possibly the day(s) prior to the party, or for other maintenance needs. In which case, full refunds will be given for any fees paid or parties may be rescheduled if possible.
- 12 All parties must be booked at least 2 weeks prior to the party date. The Santa Clarita Skate Park is not available for party reservations on holidays or during special events. Please call ahead to find out available dates to book parties (661) 250-3700.

Skate Park Regulations

- The Skate Park is for use only by riders of Skateboards, BMX Bicycles, non-motorized scooters, and rollerblades. It is unlawful for a person to enter onto or ride in the Skate Park with a motorized bicycle, motorcycle, motorized vehicle, motorized scooter, motorized skateboard, or any device other than a skateboard, BMX bike, scooters or rollerblades. *Anyone riding or bringing any unauthorized device onto the park is in violation and subject to citation pursuant to the Section 12.54.040 of the City's Municipal Code.*
- Skateboarding, Scootering, Rollerblading, and BMX Bicycling are hazardous recreational activities. Skateboarding, Scootering, rollerblading, and BMX Bicycling at the Skate Park, or at other locations within the City is a hazardous recreational activity for participants, and the City of Santa Clarita will assert all defenses available at law or equity in connection with any injuries or property damage incurred in connection with such hazardous recreational activity.
- All Skate Park users are required to wear helmets, kneepads, and elbow pads. *Any person failing to wear the required equipment will be subject to citation pursuant to Section 12.54.030 of the City's Municipal Code.*

The Los Angeles County Sheriff's Department is authorized to enter upon any City, public, or private property so posted to enforce the provisions of this section.



**The Skate Park may be closed by staff
for the following reasons:**

- 1. Rain**
- 2. Park damage: graffiti/vandalism**
- 3. Maintenance needs**
- 4. Unacceptable user behavior**
- 5. Continual violation of the park rules and code of conduct**

Skate Park Rules

- This is an unsupervised park
- Skateboards, BMX bicycles, non-motorized scooters, and rollerblades only – no other devices or vehicles permitted
- No motor vehicles of any kind
- No spark-emitting equipment
- Users must wear helmets, elbow pads and knee pads at all times
- No smoking
- No alcohol or drugs
- No animals
- No graffiti, stickers, or littering
- Skate park hours are posted – no exceptions unless authorized by the Parks, Recreation & Community Services (PR&CS) Director
- Keep food or drink on the perimeter path only
- No glass allowed
- Additional obstacles or other materials (ramps/jumps/trash cans) may not be used in the skate park
- All organized events shall have written approval from the PR&CS Director
- Users under the age of 12 must be accompanied by a parent due to the nature of the hazardous recreational activity occurring at the skate park
- Warning – skateboarding, scootering, BMX bicycling, and rollerskating at this facility are hazardous recreational activities. Use of this facility may result in death, paralysis, brain damage, concussion, broken bones, or other serious injury
- Use of this skate park is at your own risk
- Do not use facility if hazardous conditions exist. Report any damage/hazardous conditions to the Recreation Division or call (661) 250-3700
- Call 911 to report a crime of any kind

Anytime the Skate Park is locked it is considered closed. *Anyone caught in the Skate Park while closed will be prosecuted for trespassing. Trespassing is a class one misdemeanor punishable by 12 months in jail and/or a fine pursuant to CA Penal Code section 602.*

City of Santa Clarita Park Rules

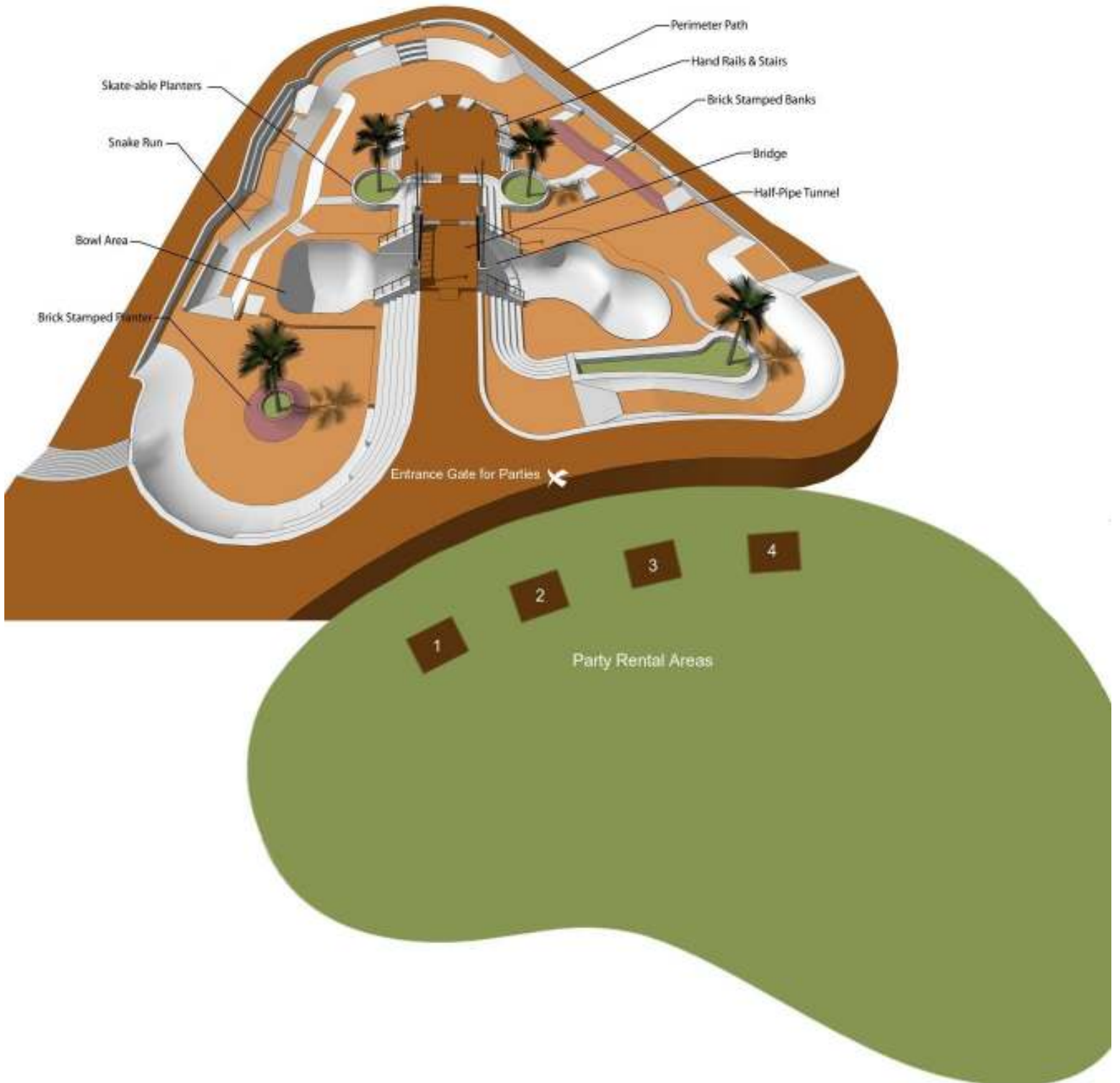
- Bikes and skateboards are only permitted in the Skate Park area.
- Dogs and other domesticated animals must be on a leash.
- Softball and baseball play are only permitted on ball diamonds set aside for that purpose.
- Alcoholic beverages and/or drugs are prohibited.
- Climbing trees is prohibited.
- Discharge of firearms or air-powered weapons is prohibited.
- Barbequing is not allowed at the Sports Complex Park.
- Operation of line-attached models, motorized or self-propelled vehicles are not allowed at the Sports Complex Park.
- Overnight parking and camping are prohibited.
- Motorcycles or other motorized vehicles are prohibited on park grounds.
- Anyone caught doing malicious damage to park property will be prosecuted under section 594 of the penal code, State of California.

Violations of the above rules are an infraction and/or misdemeanor and are punishable by fine or imprisonment per Santa Clarita Municipal Code, Title 14.
